Scope and Content

The materials in FOIA 2016-0310-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0310-F requested classified records from the United States Trade Representative regarding the Central America Free Trade Agreement (CAFTA) and the Free Trade Area of the Americas (FTAA).

This FOIA primarily contains cover sheets, routing documents, administrative printed emails, documents relating to the approval of a travel request, letters of support for CAFTA, letters

regarding FTAA from Congress and the Coalition for Sugar Reform, and responses to those letters from United States Trade Representative Robert Zoellick.

It should be noted that many of the documents listed here may have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

System of Arrangement

The materials in FOIA 2016-0310-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) and Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
