I had met you several times. I lobby for nursing homes and am Pete Buigas' partner. Anyway I am a recalled reservist serving as a Corpsman (medic) to a Marine Corps unit in Ramadi Iraq and have a story you might enjoy.

I and my other Corpsman primarily care for Iraqi civilians and detainees. Many of them who come to our sickcall are not sick but just worn down by living with war. Then there are some whose conditions are such there is little we can do for them. One thing we do to is to give them listerine breath strips. We tell them that it is secret american medicine (duwa). We tell them it is "George Bush duwa." Now when the Iraqis line up for sickcall and they want their breath strips they say "I love George Bush" and "George Bush good". Just doing our part to help your brother's poll numbers here in Iraq. Take care and good luck with the hurricane.
