### **Extent**

### **Access**

Bush Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

### **Copyright**

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

### **Provenance**

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

The materials in FOIA 2016-0307-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0307-F requested unclassified textual records from the United States Trade Representative on the Central American Free Trade Agreement (CAFTA) and the Free Trade Area of the Americas (FTAA).

This FOIA primarily contains a letter from Robert Zoellick to President George W. Bush thanking him for his hospitality during his swearing-in, letters transmitting formal reports, routing memos, and a copy of the publically available report of the Advisory Committee on

Trade Policy and Negotiations on the proposed free trade agreement between the United States and the Dominican Republic.

**System of Arrangement**

The materials in FOIA 2016-0307-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.
