Scope and Content

The materials in FOIA 2014-0359-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0359- F contains materials related to records created by or sent to Isaac Hunt, SEC Commissioner.

This FOIA primarily contains correspondence, fax transmittal sheets, memoranda, articles, and letters mainly sent to Karl Rove. They consist of correspondence with Karl Rove including a request for a Presidential letter, invitations, articles, agendas, and drafts. Also included are printed emails, an invitation to President and Mrs. Bush with background information, and letters to SEC Chairman Arthur Levitt. Email consists of invitations to a reception for the International Institute for Securities Market Development, hosted by the SEC.

System of Arrangement

The materials in FOIA 2014-0359-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) and George W. Bush Presidential Electronic Records

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
