The President has asked that the Department of State respond to your letter of July 24 regarding the issue of sending U.S. troops to Liberia.

The situation in Liberia is a major concern to the United States, and we are actively considering how we can best support international efforts to help Liberia return to peace and the rule of law. As President Bush pledged on July 30, "... [the United States] will... take the necessary steps to get ECOWAS in place so that we can deliver aid and help to suffering Liberians." On August 14, U.S. Marines secured Roberts Field and assisted Nigerian forces in securing the port. We will continue to coordinate with ECOWAS on how to facilitate the deployment of further peacekeeping forces to the country and support the ECOWAS mission. In addition a U.S. military team is in Monrovia to assess how best to address Liberia's humanitarian situation, and the Iwo Jima Marine Expeditionary Unit remains offshore.

Our immediate priorities in Liberia are to achieve peace, stop the bloodshed, and address humanitarian concerns. To accomplish this, as the President has said, Mr. Taylor had to leave Liberia. He has now done so. We hope this now allows us, in coordination with the ECOWAS forces, to put in place the security and political situation in the country to start relief efforts and begin to rebuild Liberia.

Much remains to be done in order to achieve our longer-term goals. All combatants must be disarmed, demobilized, and reintegrated into society, and the security services must be restructured and retrained. Liberia's economy and infrastructure must be rebuilt, the government must be made transparent, and the environment
