Calvin William Verity was born in Middletown, Ohio, on January 26, 1917. He ol in economics from Yale University (1939). Verity worked in advertising for Youn Rubican, managed the Hapsburg House restaurant, and went on to his grandfa company.

He served the U.S. Navy as a lieutenant in the Pacific (1942-1946), and then re Armco. He progressed from handling personnel, to director of organizational pla development (1957), to director of public relations (1961), to vice president and manager of steel (1964), to executive vice president of Armco (1965), and finall of Armco's board (1971).

Verity was also chairman of the U.S. Chamber of Commerce (1980-1981), chai Reagan's bipartisan task force on Private Sector Initiatives (1981), and cochair U.S.S.R. Trade Economic Council (1979-1984).

In the latter years of the Reagan administration, he served as secretary of comi 1989).
