**Abstract:** White House Office of Records Management Subject Files relating to the drafting, issuing, and distribution of Presidential Proclamations, created and maintained during the administration of George W. Bush.

**Access:** Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 22) and therefore records may be restricted in whole or part in accordance with legal exemptions. Access is fully restricted.

**Copyright:** Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. **Custodial History:** Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

**Administrative History:** The White House Office of Records Management is responsible for the filing and retrieval of records created during the incumbent presidential administration. The use of a filing methodology for records created or received by the White House dates to at least the early years of the 20<sup>th</sup> century, and has undergone changes since that time to cope with the ever-expanding volume of paperwork handled by the President and his staff.

The White House Office of Records Management, or ORM (or WHORM) manages the office files of individual White House staff members, as well as administration records that are arranged by subject code and case file ID number according to their general subject matter.

**Scope and Content Note:** This series consists of material relating to the drafting, issuing, and distribution of proclamations produced during the administration of George W. Bush, including records produced during the drafting of the proclamations, requests for copies of ceremonial proclamations, and requests for the issuance of Presidential proclamations.

This series includes invitations, emails, letters, memorandums, press releases, publications, speeches, and web pages.

This collection is only partially processed and some boxes may be unavailable for research.
