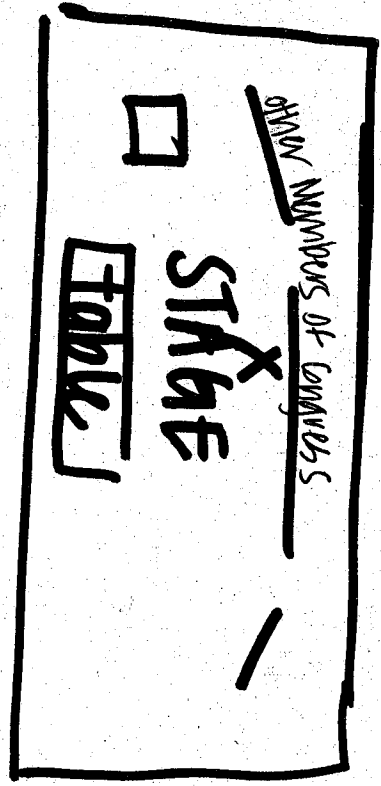

I. PURPOSE

To sign H.R. 5140, the Economic Stimulus Act of 2008.

II. BACKGROUND

H.R. 5140 is the bipartisan economic growth compromise legislation. This bill meets the criteria set out by your Administration, and will help to stimulate consumer spending and accelerate business investment.

The bill passed the Senate by a vote of 81-16 and cleared the House by a vote of 380-34 on February 7.

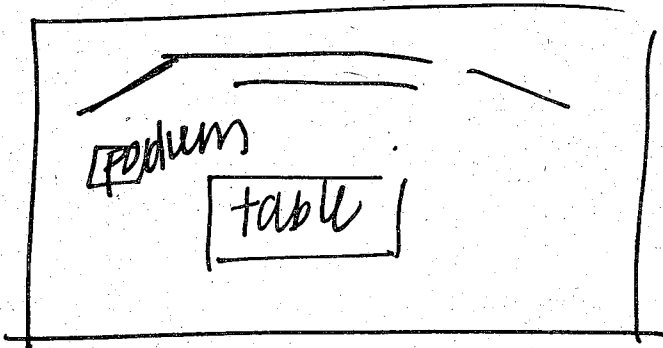
