Scope and Content

The materials in FOIA 2014-0216-F[1] are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0216-F[1] requested materials to and from President Bush regarding certain members of his Cabinet. While the records in this segment touch upon most or all of the administration's cabinet heads, the majority concern Alberto Gonzales, Andrew Card, or Condoleezza Rice.

This first segment of this FOIA primarily contains correspondence to the President and/or his advisors, presidential scheduling and briefing materials, speech drafts, presidential message drafts, memoranda to the President on various issues, and personnel records. Researchers should

be aware that, due to the nature of this request, the records are only loosely related to each other. The material concerns a particular cabinet member in some way, but very little of it is substantively about that person.

System of Arrangement

The materials in FOIA 2014-0216-F[1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) and Staff Member Office Files (SMOF).

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu.
