FOIA 2014-0446-F contains materials related to emails between the Department of Veterans Affairs (VA) and the Office of Management and Budget (OMB) regarding multiple topics.

This FOIA primarily contains legislative referral memoranda regarding testimony, draft bills, letters to Senators, and reports. Additionally, there are memoranda regarding the Paperwork Reduction Act, logistical information regarding a retreat including an agenda and departure/arrival location, a message coordinating the Interagency Response Coordination meeting with Deputy Secretaries, a summary and follow-up regarding the President's

Management Agenda, messages transmitting Capitol Hill legislative reports, and a message transmitting the VA results report in 2004.

**System of Arrangement**

The materials in FOIA 2014-0446-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
