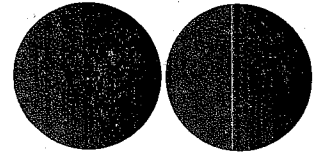

Iraqi Opposition Group Says It Tried to Kill Hussein's Son

LONDON, Aug. 14 -- The Iraqi National Congress exile group said today that its operatives shot and wounded the youngest son of Iraqi President Saddam Hussein during an assassination attempt two weeks ago.

"Qusay was an obvious target for assassination," said a spokesman for the group, which is based in London and includes most of the opposition factions. "He is the second man in command in Iraq, a war criminal who cleansed prisons and put down revolts brutally."

Qusay Hussein heads the Republican Guards, Iraq's best-trained and best-equipped army unit, which is entrusted with protecting the president. He has been promoted to the regional command of the Baath Party and touted as a possible successor to his father.

The Iraqi National Congress spokesman said Qusay was wounded in the arm when a gunman shot at his motorcade in the Mansour district of Baghdad on Aug. 1.

Iraqi security forces clashed with the attackers, who fled the scene, he added.

No comment was immediately available from Iraqi officials. There was no independent confirmation that an assassination attempt took place.

Like his father, Qusay rarely appears in public, and he avoids publicity - unlike his brother Uday, who owns at least one newspaper as well as television and radio stations. Uday was wounded in an assassination
