Scope and Content

The materials in FOIA 2014-0149-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0149-F contains materials related to Joseph Hagin's records regarding the Enduring Constitutional Government (ECG) and Enduring Constitutional Government Coordinating Council (ECGCC).

This FOIA primarily contains email messages sent to or from Joseph Whitehouse "Joe" Hagin II during his tenure as Deputy Chief of Staff. Responsive records include the topic of continuity of government operations in emergency situations. The email messages include discussions on

scheduling meetings and determining meeting agendas. Also included are Legislative Referral Memoranda (LRM) seeking comment on draft testimony from Michael Brown, Undersecretary at FEMA, on continuity issues; a draft Executive Order for Critical Infrastructure Protection, which was eventually issued as E.O. 13231; and memoranda on continuity of government operations.

System of Arrangement

The materials in FOIA 2014-0149-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
