United Nations Secretary General Luncheon Toast September 23, 2003 Draft #4

Mr. Secretary-General, distinguished members of the United Nations community, excellencies, ladies and gentlemen: Thank you for your welcome to the United Nations. America is honored that all of you are here. Since the founding of the UN more than fifty years ago, my country has been proud to host this organization. And I am pleased to join with you in opening the 58th session of the UN General Assembly.

Mr. Secretary General, I am grateful for your leadership. From Afghanistan, to Iraq, to Liberia and beyond, the United Nations is helping to rebuild shattered nations and bring hope to millions. And the United Nations has suffered great loss in this cause. The terrorist attack against the UN headquarters in Baghdad took the lives of twenty-two servants of peace - including Sergio Vieira de Mello, a man who dedicated his life to promoting human rights throughout the world. The people of my country mourn with you. And we share your resolve to continue their important work.

The two years since the September 11th attacks have been a time of testing for all of us. New and ruthless enemies threaten our nations, our cities, our citizens, and our freedoms. Poverty, disease, and oppression challenge our conscience. We gather in this city, at this Assembly, to meet the urgent challenges of our time. Working together, we are making progress against these enemies of human dignity.

Together, we can defeat terror. We can help bring peace to regions where conflict undermines hope. And we can serve the cause of freedom, which leads to true peace among nations.

Mr. Secretary-General: With admiration for you, and confidence in the future of this organization, I offer this toast to the United Nations.
