FOIA 2018-0279-F requested materials related to a meeting between Frank Miller of the National Security Council and Danish Ambassador Ulrik Federspiel on March 18, 2003.

This FOIA primarily contains emails consisting of Worker and Visitor Entry System (WAVES) appointment reports for the admission of Ambassador Federspiel into the White House and the WAVES XML file containing the same information. No documents contain information about the content of this meeting.

System of Arrangement

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
