FOIA 2016-0247-F contains materials related to emails between White House email addresses and Donald J. Trump, or staff of the Donald J. Trump organization, between October 1, 2002 and March 23, 2003.

This FOIA primarily contains copies of an email sending around a new email address for an employee of Trump Plaza Hotel & Casino.

System of Arrangement

The materials in FOIA 2016-0247-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.







The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
